

EXPO-PLUS provides affordable and comprehensive coverage with limits up to \$40 million. It's designed to insure you against the financial losses you would face if:

- ✓ Your event is disrupted due to civil commotion (Upon request: this may not be available through other providers)

- ✓ Weather or travel mishaps reduce your anticipated attendance
- ✓ Your keynote speaker or main attraction is a no-show

These benefits may also be customized to fit your event needs:

Severe Weather Conditions: Additional coverage up to the full limit of indemnity for covered snowstorms (including ice storms), hurricanes, tornadoes, wildfires, flooding, etc. can be included for outdoor events.

Civil Commotion: This coverage may not be available through other providers.

Labor Disputes: Including strikes by airline, hotel or transit workers.

Limited Terrorism (including threat): \$1,000,000 or limit of indemnity, within 250 miles and 100 days of the event, whichever is less, is included in the policy. Increased limits and options are available.

Earthquake: Coverage up to the limit of indemnity.

Outdoor Team Building/Recreational Event: Up to \$125,000, should the insured event be canceled for reasons beyond your control.

Emergency Travel Arrangements: Up to \$75,000 for return of participants back to venue should the prearranged transportation of the participants be canceled for any reason beyond their control.

Enforced Reduced Attendance of Attendees, Exhibitors, etc.

Insured Commitments: In addition to limit of liability, up to 15% extra is available for those financial commitments you have entered into and undertaken by others on your behalf.

If your commitments are greater than 15%, our underwriters will consider extending this to suit your needs.

Golf Event Cancellation: Coverage up to \$100,000 due to adverse weather should your day be canceled.

Golf Hole in One: Up to \$50,000 if you arrange a "prize" for par three hole not less than 175 yards, or 165 for ladies, should you wish to enhance your Golf Event.

National Mourning: Coverage following the death of the president of the United States.
